



# AEIG's Full Mortality Policy Highlights

- ✓ Free Emergency Colic Surgery coverage included on all full mortality policies. This coverage is primary to any medical/surgical coverage. Annual limit of \$3,000 or 60% of the horse's insured value, whichever is less. Coverage void for horses with a history of colic within 12 months of coverage effective date.
- ✓ Free 12-month extension on all full mortality policies. This coverage provides an additional 12 months of mortality coverage for any health condition claimed within the policy year, whether or not the policy is renewed.
- ✓ Free EquineValue endorsement on all full mortality policies.
- ✓ Zero Deductible Surgical coverage can be stacked with any EMS limit or with Cat Med. Horse's insured value must meet or exceed combined medical/surgical limit.
- ✓ No vet exam required on sound, healthy horses aged 31 days through 20 years with insured values of \$100k or less.
